



PIZZA FOR A YEAR Giveaway – February 2018

Official Rules. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THE GIVEAWAY (the “Sweepstakes”). A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.

You agree that, by submitting any entry, you will be bound by these Official Rules and you acknowledge that you satisfy all sweepstakes eligibility requirements.

Eligibility. If you are an individual legal resident of the State of Florida and are 18 or older at the time of entry, you are eligible to enter the Sweepstakes. All Hungry Howie’s employees, their immediate family members (spouse, domestic partners, parents, grandparents, siblings, children and grandchildren), advisors or advertising/promotion agencies (and their immediate family members) are not eligible to enter the Sweepstakes. Prize winners will be required to sign a document confirming their eligibility as outlined above.

Prize. We will award a total of fifty two (52) Large 1-Topping Pizza Certificates, good for carry-out only (retail price value of at least \$415). The winner will be responsible for paying any costs and expenses related to the prize that are not specifically mentioned, including, but not limited to, taxes and any other expenses that might reasonably be incurred by such winner in receiving or using the prize.

Prize Drawing. The potential prize winner will be selected at a random drawing to be held on or about 3 p.m. on Wednesday, February 28, 2018. We will notify the potential winner by the contact information provided on the survey within 1 business day following the drawing, with instructions about how they can claim their prize at a participating Hungry Howie’s location. We will select an alternative potential winner if the winner does not claim the prize within 5 days of notification, or meet the eligibility criteria.

Odds of Winning. Odds of winning depend on the number of eligible entries received from 8 participating locations.

Additional Terms. We may, to the maximum extent permitted by applicable law and in our sole discretion, change these rules or suspend or cancel the Sweepstakes at any time. We are not responsible for: (a) lost, misdirected, late, incomplete, or unintelligible entries or for inaccurate entry information, whether caused by you or by any of the equipment or programming associated with or utilized in the Sweepstakes, or by any technical or human error that may occur in the processing of entries; (b) any printing or typographical errors in any materials associated with the Sweepstakes; or (c) any error in the operation or transmission, theft, destruction, unauthorized access to, or alteration of, entries. We may, in our sole discretion, disqualify any individual found to be: (x) tampering with the entry process or the operation of the Sweepstakes; (y) acting in violation of these rules; or (z) acting in any unsportsmanlike or disruptive manner or with intent to annoy, abuse, threaten or harass
